We would like to invite you to the public discussion Moldova's progress on the path to the EU membership negotiations on May 30 at 11 AM, Mercure Chisinau Center Jazz Hotel in Chişinău.

The event will take place in the framework of the project Eastern Partnership Plus, funded by the German Foreign Office and organized by the Center for Liberal Modernity in cooperation with the Foreign Policy Association and Expert-Grup in Moldova.

On 14-15 December 2023, the European Council decided to open accession negotiations with the Republic of Moldova if progress can be made in implementing EU reforms, particularly in the Rule of Law. Since then, the Moldovan government has been continuously implementing the EU reforms. How should Moldova's progress towards EU accession negotiations be assessed? What are the next steps in the EU integration process for Moldova? How can the EU and Germany support and accompany Moldova on its European path? What is the state of security co-operation between the EU and Moldova and what should be done?

We would like to discuss these questions with the member of the Bundestag, representatives of the European External Action Service and the Moldovan government as well as participants of Moldavian civil society.
